RCG is committed to empowering workers through a culture of health, safety, and wellbeing (HSW) best practice by:

- 爨 Providing appropriate training, equipment, and resources for each person and job.
- 爨 Creating and maintaining a safe and healthy work environment.
- 爨 Managing reporting and investigation of incidents and near misses.
- Assisting and advising our people to identify hazards and risks and manage effective controls.
- 爨 Effective consultation with partners, contractors, and suppliers as complementary Person Conducting a Business or Undertaking.
- 钁 Effective consultation with our workers on HSW.
- 爨 Ensuring health and safety information is provided to all our workers, contractors, suppliers, and visitors.
- 钁 Continuously improving by setting and reporting on measurable health and safety objectives and targets.
